2.2 Competition Format

1st day, Saturday, November 17th

Juniors Qualification (IW)
Seniors Qualification (IM/IW/DO)

The top ten of all categories may participate in the finals.

2nd day, Sunday, November 18th

World Championship Junior Finals World Championship Senior, Doubles & Master's Finals World Championship ParaPole

2.3 Qualifications

- Starting order of the competition (qualifications), will be done between the 1st and 2nd of November 2018, just after the deadline of athlete applications (31st of October), by the official representatives of the POSA.
- If a National Federation reduces the number of participating athletes after the definitive inscriptions, the POSA/TC has the right to adjust the starting order to ensure the best possible running of the competition.

2.4 Qualifications for the CSIT- World Sports Games 2019

As agreed between POSA and CSIT, the top ten (10) athletes (in each category) in the ranking, have the right to participate in the CSIT- World Sport Games 2019 in Tortosa (Spain).

2.5 POSA World Pole Sport Championship Finals

- The finals will take place on Sunday, November 18th, as follows:
 - World Championship Juniors Finals, 09h00 to 12h15 (9:00AM 12:15PM)
 - World Championship Seniors, Master's & ParaPole Finals, 13h15 to 19h30 (1:15PM 7:30PM.

The top ten from all categories will qualify for the finals.

In case of a tie at any position at the end of the qualification, see POSA Code of Points.

The order of all categories for competitions in the finals as follows:

• Juniors, Seniors, Masters, ParaPole;

The list of the finalists, including **two reserves**, will be delivered to the head of delegation after each qualification.

2.6 Access to the Competition Area

- The competition area is accessible to members of the various juries, competing athletes and their accredited coaches, to local group leaders, to the auxiliary personnel of the Jury, to the President of the POSA Medical Commission, the official doctor, the team doctors, medical staff and to persons concerned with the apparatus
- Interpreters may not enter the competition area without the permission of the President of the POSA/TC.
- The competition area is strictly forbidden to all other persons.
- The use of any kind of electronic devices (video, mobile phones, etc.) is strictly forbidden in the competition area. Please note that, according to the decision of the Executive Committee of POSA, if a mobile phone or any other electronic communication device is used in the competition area during the entire competition, the person concerned (athlete and/or coach) will be immediately expelled. The athlete will not be ranked and will not be authorized to participate in the remaining competitions. If this rule is violated by a coach, all his/her athletes will also be expelled.

2.7 Award Ceremonies

The ceremonies in the competition venue will take place as follows:

- For Junior WCH on Sunday, November 18th, at 11h45 (11:45AM) for IW, IM & Doubles;
- For Senior, Master's & ParaPole WCH on Sunday, November 17th, at 19h00 (7:00PM) for all categories;

2.8 Pole Supplier

The competition podium and warm up rooms have POSA official poles supplied by the official Pole Sponsor only.

2.9 Scoring and Distribution of Results

Once the competition has finished, all delegations will be provided with a complete set of results including the judges' individual scores for all competitions.

2.10 <u>List of Difficulty Elements</u>

At the accreditation, the Heads of Delegation must give the list of difficulty elements (Difficulty Sheet), for each competitor(s) by each category (Seniors and Juniors). Athletes, however, must send their "Difficulty Sheet" to the Athlete Chair by the deadline of October 31st email: athletechair@usapolesports.org

2.11 Competition Attire Publicity

Any advertisement displayed on any track suit or costume worn by a competitor must be approved at the orientation meeting by the Head Judges (according to the POSA rules of publicity).

2.12 Music

To limit the technical problems with the music used for the competitions, the Organizing Committee has decided to only accept the athlete's music in an MP3 format only (CD, USB sticks etc. are accepted). All music used during the 3rd Pole Sports World Championships must be submitted online, via email with the form attached in this Work plan, until October 31st, 2018. Music can be submitted electronically via a drop box link or as an attachment to athletechair@usapolesports.org

Each music file will have to contain the following information:

- The name of the nation (official abbreviation of the country);
- The first and last name of the competitor/s;
- The category;
- The length of the music;
- The Junior or Senior (Example: ROU RADU Alina Junior IW2 3min30s mp3)

The Head of Delegation or the coach must sign two forms on behalf of the competitor to:

- approve the technical criteria for the music to be played by the organiser;
- quarantee that the piece of music chosen and supplied is not forbidden to be played during a sports event.

The Heads of Delegation must hand in the Music Release Form during the accreditation. (App. D)

2.13 Doping Control

Any doping is prohibited. A doping control test can be requested at any time, in accordance with the POSA regulations. Doping controls will be carried out in accordance with the WADA-NADO regulations.

3.3 Judges' instruction and draw of lots

All judges must participate in the briefing sessions as described in the Competition Schedule. Short judges' briefings will take place before each competition.

- According to the POSA Rules, the presence of the judges to the judges' instruction is mandatory.
 The judges' instruction will be held in English.
- The judges' oath will be carried out at the end of the judges' instruction, by one of the host federation judge.

3.4 Judges' Meetings

According to the Competition Schedule Above

3.5 Inquiries Procedure

Inquiries for the difficulty scores will be allowed, if they will be made verbally, immediately after the publication of the score or at the very latest before the end of the routine of the following athlete. For the last athlete of a rotation (rotation=group of athletes, for example 1st Group of athletes during the competition, this is called "rotation"), this limit is one minute after the score is shown on the scoreboard. The person designated to receive the verbal inquiry will have to note the time of receiving it and this will start the procedure. Only the accredited coaches present in the competition area will be entitled to submit an inquiry. Late verbal inquiries will be rejected.

A federation will not be allowed to complain against an athlete from another federation. The inquiry will have to be confirmed as soon as possible in writing, but within 4 minutes at the latest after the verbal inquiry and will require an agreement of payment of EUR 150—for the first complaint, EUR 300 — for the second complaint and EUR 600— for the third complaint. Should the inquiry not be confirmed in writing within 4 minutes, then the procedure will become obsolete.

Should the inquiry prove correct and be accepted, this sum will be reimbursed. Every inquiry will be examined by the Superior Jury and a final decision, which may not be appealed, will be taken at the very latest:

- At the end of the rotation for the qualifying competitions, or at the end of all around competitions.
- Before the score of the following athlete is shown for the finals.

The detailed procedure is laid out in the respective POSA Code of Points.

3.6 Tie Breaking Rule

- In case of a tie at any position at the end of the qualification see POSA Code of Points
- In case of a tie at any position at the end of finals see POSA Code of Points

For any delegation it's possible to bring one more athlete per individual category, as reserve. This athlete must pay the application fee as any other athlete.

Doubles: In case of injury or renunciation of one of the two qualified Doubles members, it is possible for them to replace the resigning athlete with a different athlete (all this must be communicated via email to posaworldfederation@gmail.com & athletechair@usapolesports.org). POSA wants to give the opportunity to the Doubles athlete who has remained without a partner (but who is qualified by law), to compete in any case. If this is not possible, athletes must communicate as soon as possible, their renunciation to compete, to give way to Doubles number 4 in their national ranking, to be able to compete at the World Championship.

If no announcement is received by athletes or the National Federation within the established deadline, the National Team will no longer have the right to enter any other Doubles in the competition, replacing the renouncing Doubles. Deadline for all these communications: October 15th, 2018.

4.3 Accreditation & Registration

Accreditation and registration permits the identification of all participants and indicates the access to certain zones. Access to all zones will be controlled. Badges must be visibly worn throughout the whole event. During the accreditation the Heads of Delegation will verify the identity of the members of their delegation as well as all requirements regarding accommodation, meals and registrations. They must make the necessary payments, hand over the back-up thumb drives for their athletes, the thumb drive with the national anthem and their national flag. *The LOC requires all Federations to bring thumb drives only.*

Registration will be carried out upon arrival. The registration check in booth will be on the third story lobby of the Convention Center. This area is right in front of the main competition hall. The accreditation/registration is personal, non-transferable and necessary for access to the training and competition halls. POSA Directives and Technical Regulations will be strictly applied, especially about the number of persons accredited per nation.

Accreditations are provided to each delegation having fulfilled their financial obligations. Athletes Application fee:

All individual categories application fee is \$75 USD; Doubles Category fee is \$100 USD (\$50 per athlete); Coach Registration fee is \$25 USD

To register for the Pole Sport Worlds Championships 2018 the National Federation must complete the forms attached with the work plan.

- National Federation Registration Form (2 Pages)
- Music Forms for each athlete and submission of the their music to the Athlete Chair
- National Anthem submitted to the Athlete Chair. Clearly mark the National Anthem with the name
 of the country. (Example: National Anthem Ukraine)
- Proof of payment to confirm that the athletes attending have paid the registration fee via link in POSA site or bank transfer.
- Difficulty Sheets for each athlete have been submitted to the Athlete Chair.
- Copy of Passport for each athlete (JPEG format)
- Picture of each member of the delegation, Coach or medical staff member attending within your registration (JPEG format)

Registration will not be accepted past October 31, 2018 12PM EST

Upon accreditation and acceptance of your national federations registration, the Head of Delegation is responsible for providing to the organizing committee the following:

- The medical insurance for the members of the delegation if not already provided.
- Bring music on a thumb drive. The thumb drives will be returned to the Heads of Delegation after the athlete last competition. It is recommended that spare thumb drive be brought for safety reasons.
- National Flag for the opening ceremonies. Flag must not be bigger than 3ft x 5ft. Recommended size is 3ft x 5ft as the hosting organization will supply the sticks to attach to the flag. Please get a flag that has grommet holes at the top and bottom to attach.
- A copy of the Medical Certificate/Diploma for medical personnel. POSA will collect and record

these certificates. Please note that without this document, the accreditation of the medical personnel will NOT be released.

- For the accreditation process, only the Head of Delegation (or his representative) or the coach is requested to present him/her self at the Registration Center.
- Official email to send accreditations and payment receipt: president@usapolesports.org

4.4 Orientation Meeting

This orientation meeting for all delegations will take place on Friday, November 16th, 2018 at 18h30 – 19h30 (6:30PM – 7:30PM) the at the competition venue. The Heads of Delegation, Coaches and athletes will need to participate in this briefing session, during which the POSA TC and the LOC will give information about the running of the championships. An updated work plan will be distributed to the Heads of Delegation during the orientation meeting. This orientation meeting will be held in English only.

4.5 <u>Training Information</u>

The training will start on Thursday, November 15th, 2018 and will take place in the competition hall. A detailed timetable for the warm-up will be handed out to the Heads of Delegation before their arrival. The timetable of the training and the warm-up of the finalists will be given to the Heads of Delegation via email prior to the competition. The access to the competition hall, the training and the warm-up halls will only be granted to those delegations wearing the accreditation card and only during the times reserved for their nation.

4.6 Opening Ceremony

The Official Opening Ceremony will be held on November 16th for Juniors, Seniors, Masters & ParaPole, in the Competition Hall at 09h00. The ceremony will consist of Flags Presentation by nation with the competitors by nation performing a special greeting for the audience. **All competitors must wear their national tracksuit**.

4.7 <u>Delegation Boxes</u>

- Delegation Mail Boxes will be set up in the competition hall. All information regarding competition, warm-up, trainings, and notification of meetings, transport, official functions, as well as POSA & LOC correspondences will be distributed via the delegation mailboxes.
- A special "Mail Box" authority card will be issued to each Head of Delegation. This card must be shown by the Head of Delegation (or his representative) when collecting all information and results from their Delegation Mail Box. The delegation member designated to collect the information from the Delegation Mail Box will be required to sign for information collected.

4.8 Medical Services

The LOC will provide the necessary medical services.

4.9 Farewell Party

The closing event will be organised on Sunday night, November 17th, with time and venue to be confirmed upon arrival.

POSA Technical Regulations stipulate that all participating federations or athletes, must assume all costs in relation to the medical insurance of all delegation members (illness and accidents). The Local Organising Committee has the right to verify the validity of the insurance upon arrival of the delegations (policy insurance, original or copy).

Entering the World Championships without valid medical insurance of all delegation members will be rejected.

4.13 Visa

Please check whether you need a visa to enter the USA. The Local Organising Committee will assist you applying for a visa with pleasure. The committee has also prepared an official invitation that can be sent to those who need it for their Visa applications.

4.14 Regulations

The 3rd POSA Pole Sport World Championships for Juniors, Seniors, Master's and ParaPole, in Fort Lauderdale (USA), 2018, will take place under the following regulations;

- The current Codes of Points and the followings remarks, or documents issued by the POSA/PS TC;
- WADA Internationals Regulations;
- The 2018 POSA General Judges' Rules (Code of Ethics).
